Student/Parent Memorandum of Understanding

General Use

I understand I must bring my iPad to school every day so it is available for when my teacher requires me to use it as a learning tool.

I understand that I may not use my iPad every day, however I still need to develop a routine and have it at school every day.

I will ensure my iPad is charged at the beginning of each school day.

I will leave my iPad charger at home unless directed to bring it to school under special circumstances.

I will hold my iPad with two hands when carrying it and will walk with it at all times.

I will ensure my iPad is kept in my school bag on the journey to/from school and before and after school.

I understand that my iPad is only to be used as a tool for learning and that I will not use it during break times.

I will keep food and drinks away from the iPad at school.

I will immediately report any accidents or breakages to my parents and teachers.

Content

I will only use my iPad as a tool for learning at Eagle Junction State School.

I permit my teachers and parents to perform checks to monitor that I have not installed illegal /unsuitable software applications, content and to allow them to check the websites which I visit.

I understand there will be consequences for inappropriate use including, but not limited to, loss of privilege of using the iPad for a period of time.

I am responsible to ensure my iPad is backed up.

Safety and Security

Whilst at school, I will only connect my iPad to Eagle Junction State School's internet network.

I understand that I am not permitted to access 3G/4G/5G Internet at school.

Whilst at school, I will only visit websites and apps that my teacher directs me to and which supports my learning.

I will use the school email and network in a responsible and appropriate manner.

I am aware that my school digital behaviours are monitored by the school to ensure safe and appropriate use.

I will check with my teacher or any Eagle Junction State School staff member if I find, observe or experience anything that may be unsafe, disrespectful or inappropriate on my personal iPad, on a school device or any other student's device.

I will report any digital device problems to my teacher or Eagle Junction State School staff member promptly.

I will be cybersafe and cybersmart when using my iPad.

I will use my iPad lawfully and in accordance with the appropriate use guidelines regarding ethical use of digital devices.

For security reasons, I will not share account names and passwords with anyone unless requested by Eagle Junction State School staff when servicing the iPad.

I am responsible for the security and use of my iPad while at Eagle Junction State School.

I will follow the school rules by being **Respectful, Responsible, Safe, Resilient and Confident** when using digital devices both at school and at home.

I understand if the above conditions are breached, I may lose my privilege to access my iPad at Eagle Junction State School for such time, determined by the school.
